This Privacy Policy applies only to our online activities and is valid for users of our applications, services and platforms with regards to the information that they shared and/or collect in SlideLizard. This policy is not applicable to any information collected offline or via channels other than this application.

Consent

By using our applications, services or platforms, you hereby consent to our Privacy Policy and agree to its terms.

Information we collect

The personal information that you are asked to provide, and the reasons why you are asked to provide it, will be made clear to you at the point we ask you to provide your personal information.

If you contact us directly, we may receive additional information about you such as your name, email address, phone number, the contents of the message and/or attachments you may send us, and any other information you may choose to provide. When you register for an Account, we may ask for your contact information, including items such as name, company name and email address.

How we use your information

We use the information we collect in various ways, including to:

- Provide, operate, and maintain our applications, services and platforms
- Improve, personalize, and expand our applications, services and platforms
- Understand and analyze how you use our applications, services and platforms
- Develop new products, services, features, and functionality

Cookies and Web Beacons

Like any other applications, services and platforms, SlideLizard uses 'cookies'. These cookies are used to store information including visitors' preferences, and the pages on the application that the visitor accessed or visited. The information is used to optimize the users' experience by customizing our web page content based on visitors' browser type and/or other information.

GDPR Data Protection Rights

We would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that we correct any information you believe is inaccurate. You also have the right to request that we complete the information you believe is incomplete.

The right to erasure – You have the right to request that we erase your personal data, under certain conditions.
